 staff) who move between buildings keep a log or calendar with a
 running four-week history of their time in each school building and
 who they were in contact with at each site.

1b. HIGH-RISK POPULATIONS

Medically Fragile, Complex and Nursing-Dependent Student Requirements

- All districts must account for students who have health conditions that require additional nursing services. Oregon law (ORS 336.201) defines three levels of severity related to required nursing services:
 - Medically Complex: Are students who may have an unstable health condition and who may require daily professional nursing services.
 - Medically Fragile: Are students who may have a lifethreatening health condition and who may require immediate professional nursing services.
 - 3. Nursing-Dependent: Are students who have an unstable or life-threatening health condition and who require daily, direct, and continuous professional nursing services.
- Staff and school administrators, in partnership with school nurses, or other school health providers, should work with interdisciplinary teams to address individual student needs. The school registered nurse (RN) is responsible for nursing care provided to individual students as outlined in ODE guidance and state law:
 - Communicate with parents and health care providers to determine return to school status and current needs of the student.
 - Coordinate and update other health services the student may be receiving in addition to nursing services. This may include speech language pathology, occupational therapy, physical therapy, as well as behavioral and mental health services.
 - Modify Health Management Plans, Care Plans, IEPs, or 504 or other student-level medical plans, as indicated, to address current health care considerations.
 - The RN practicing in the school setting should be supported to remain up to date on current guidelines and access professional support such as evidence-based resources from the Oregon School Nurses Association.
 - Service provision should consider health and safety as well as legal standards.
 - Appropriate medical-grade personal protective equipment (PPE) should be made available to <u>nurses and other health</u> <u>providers</u>.
 - Work with an interdisciplinary team to meet requirements of ADA and FAPE.
 - High-risk individuals may meet criteria for exclusion during a local health crisis.
 - Refer to updated state and national guidance and resources such as:
 - U.S. Department of Education Supplemental Fact Sheet: Addressing the Risk of COVID-19 in Preschool, Elementary and Secondary Schools While Serving Children with Disabilities from March 21, 2020.
 - ODE guidance updates for Special Education. Example from March 11, 2020.
 - OAR 581-015-2000 Special Education, requires districts to provide 'school health services and school nurse services' as part of the 'related services' in order 'to assist a child with a disability to benefit from special education.'

1c. PHYSICAL DISTANCING

OHA/ODE Requirements

- ⊠ Establish a minimum of 35 square feet per person when determining room capacity. Calculate only with usable classroom space, understanding that desks and room set-up will require use of all space in the calculation. This also applies for professional development and staff gatherings.
- Support physical distancing in all daily activities and instruction, maintaining six feet between individuals to the maximum extent
- ☑ Minimize time standing in lines and take steps to ensure that six feet of distance between students is maintained, including marking spacing on floor, one-way traffic flow in constrained spaces, etc.
- Schedule modifications to limit the number of students in the building (e.g., rotating groups by days or location, staggered schedules to avoid hallway crowding and gathering).
- ☐ Plan for students who will need additional support in learning how to maintain physical distancing requirements. Provide instruction; don't employ punitive discipline.
- Staff should maintain physical distancing during all staff meetings and conferences, or consider remote web-based meetings.

Classroom Set Up:

- Remove extra furniture to make more room
- Remove fabric-covered furniture and classroom rugs
- Assign seating to maximize physical distancing and minimize physical interaction.

To support social distancing guidelines in all daily activities and instruction we will:

- Traffic flow A one-way flow of traffic will be established and marked in all common areas of the school with the expectation students and staff will be trained and follow the traffic flow pattern. The traffic flow patterns will be designated with arrows which direction to walk, 6' spacing for appropriate distancing.
- Schedules -Students will stay in their classroom with their cohort group for most of the day. If a cohort group needs to transition to another part of the building or outside, a 5minute passing time for their schedules and transitions.
- Student instruction on distancing protocols- All staff will be trained on the appropriate health and safety ODE guidelines on social distancing. Teachers will be required to teach, practice, review, and reteach the ODE guidelines in their classrooms on a regular basis. This will include appropriate protocols during arrival, dismissal, hallway transitions, common areas, and recess.
- PE & Recess will be provided daily for each classroom. Playground protocol will be taught for following physical distancing. Activities and games will be promoted in which they can maximize physical distancing.
- Music class will be planned with non-wind instruments that are not shared.

1d. COHORTING

OHA/ODE Requirements

- ☑ Where feasible, establish stable cohorts: groups should be no larger than can be accommodated by the space available to provide 35 square feet per person, including staff.
 - The smaller the cohort, the less risk of spreading disease. As cohort groups increase in size, the risk of spreading disease
- Students cannot be part of any single cohort, or part of multiple cohorts that exceed a total of 100 people within the educational week. Schools should plan to limit cohort sizes to allow for efficient contact-tracing and minimal risk for exposure.
- ☐ Each school must have a system for daily logs to ensure contract tracing among the cohort (see section 1a of the Ready Schools, Safe Learners guidance).
- (e.g., access to restrooms, activities, common areas). Provide access to All Gender/Gender Neutral restrooms.

Hybrid/Onsite Plan

Scappoose Adventist School will have 4 cohorts: Preschool-PreK, K-1,

Preschool-PreK Cohorts: Students will be assigned to a classroom with no more than 10 students which meets the ODE 35sq. feet distancing guidelines and will remain as a cohort throughout the day.

- K-1 Cohort: Students will be assigned to a classroom with no more than 15 students which meets the ODE 35sq. feet distancing guidelines and will remain as a cohort throughout the day. Teachers will move to classrooms to teach P.E. Students will, for the most part, stay in their assigned classroom.
- 1-4 Cohort: Students will be assigned to a classroom with no more than 16 students which meets the ODE 35sq. feet distancing guidelines and will remain as a cohort throughout the day. Teachers

- Cleaning and disinfecting surfaces (e.g., desks, door handles, etc.) must be maintained between multiple student uses, even in the same cohort.
- Design cohorts such that all students (including those protected under ADA and IDEA) maintain access to general education, gradelevel academic content standards, and peers.
- Staff who interact with multiple stable cohorts must wash/sanitize their hands between interactions with different stable cohorts.

Hybrid/Onsite Plan

will move to classrooms to teach P.E. Students will, for the most part, stay in their assigned classroom.

5-8 Cohort: Students will be assigned to a classroom with no more than 19 students which meets the ODE 35sq. feet distancing guidelines and will remain as a cohort throughout the day. Teachers will move to classrooms to teach P.E. Students will, for the most part, stay in their assigned classroom.

A daily log to ensure contract tracing which will be kept for a minimum of four weeks for each cohort.

Stable Cohorts- For students to minimize interaction between cohort groups the following safety guidelines will be put into practice:

- Students will use the bathroom associated with their cohort.
- All activities except for recess & P.E. will be held in the students' classroom.
- Students will eat lunch in their classroom or respective cohort area.
- Separate arrival and dismissal times will be used for Pre-K, K-1, 1-4, 5-8 and will use separate entry points. Each classroom will be entered and dismissed separately to maintain physical distancing.
- A master recess schedule will be created to minimize interaction between different cohort groups.
- Playground equipment will be cleaned between each cohort group.
- Sanitizing & Disinfecting Surfaces- The following CDC guidelines will consistently be following:
 - All door handles, desks, counters, and materials will be cleaned if different cohorts use the area and after transitions.
 - All door handles, desks, counters, supplies and materials will be cleaned twice daily within the same cohort.

Students with Special Needs- Following the ODE guidelines, students with special needs will maintain access to general education.

Sanitizing in transitions- Staff who interact with different cohorts must wash their hands between interacting with each cohort. Each classroom and learning space will have the appropriate sanitizing supplies needed.

1e. PUBLIC HEALTH COMMUNICATION

OHA/ODE Requirements

- Communicate to staff at the start of On-Site instruction and at periodic intervals explaining infection control measures that are being implemented to prevent spread of disease.
- Develop protocols for communicating with students, families and staff who have come into close contact with a confirmed case.
 - The definition of exposure is being within 6 feet of a COVID-19 case for 15 minutes (or longer).

Communication for Parents:

Communication for students and families for infection or confirmed cases will be published on the SAS Website as written in the Scappoose Adventist School Communicable Disease Management Plan. Written communication will also be provided to families as needed.

1f. ENTRY AND SCREENING

OHA/ODE Requirements

- ☑ Direct students and staff to stay home if they, or anyone in their homes or community living spaces, have COVID-19 symptoms, or if anyone in their home or community living spaces has COVID-19. COVID-19 symptoms are as follows:
 - Primary symptoms of concern: cough, fever (temperature greater than 100.4°F) or chills, shortness of breath, or difficulty breathing.
 - Note that muscle pain, headache, sore throat, new loss of taste or smell, diarrhea, nausea, vomiting, nasal congestion, and runny nose are also symptoms often associated with COVID-19. More information about COVID-19 symptoms is available from CDC.
 - In addition to COVID-19 symptoms, students should be excluded from school for signs of other infectious diseases, per existing school policy and protocols. See pages 9-12 of OHA/ODE Communicable Disease Guidance.
 - Emergency signs that require immediate medical attention:
 - Trouble breathing
 - Persistent pain or pressure in the chest
 - New confusion or inability to awaken
 - Bluish lips or face (lighter skin); greyish lips or face (darker skin)
 - Other severe symptoms
- Screen all students and staff for symptoms on entry to bus/school every day. This can be done visually and/or with confirmation from a parent/caregiver/guardian. Staff members can self-screen and attest to their own health.
 - Anyone displaying or reporting the primary symptoms of concern must be isolated (see section 1i of the *Ready Schools*, *Safe Learners* guidance) and sent home as soon as possible.
 See table "*Planning for COVID-19 Scenarios in Schools*."
 - Additional guidance for nurses and health staff.
- Follow LPHA advice on restricting from school any student or staff known to have been exposed (e.g., by a household member) to COVID-19. See table "Planning for COVID-19 Scenarios in Schools."
- Staff or students with a chronic or baseline cough that has worsened or is not well-controlled with medication should be excluded from school. Do not exclude staff or students who have other symptoms that are chronic or baseline symptoms (e.g., asthma, allergies, etc.) from school.

Entry Screening Procedures

- Parents will fill in a daily questionnaire screening sheet that each student will present prior to entry.
- Each student will wash their hands or use hand sanitizer before entering their classroom.
- Students who exhibit symptoms will be sent to the office for further screening. The school isolation plan will be followed as needed and Planning for COVID-19 Scenarios in Schools will be followed.
- Plan for school implementation of isolation and send home protocols
 - Students will be isolated with an adult to monitor student's health.
 - o Parents will be notified to come get student
 - Planning for COVID-19 Scenarios in Schools will be followed for allowing students to return to inperson.
- Exclude students based on district protocols
- Planning for COVID-19 Scenarios in Schools will be followed for making decisions to exclude students.

1g. VISITORS/VOLUNTEERS

OHA/ODE Requirements

Hybrid/Onsite Plan

□ Restrict non-essential visitors/volunteers.

Visitor Plan

- Examples of essential visitors include: DHS Child Protective Services, Law Enforcement, etc.
- Examples of non-essential visitors/volunteers include: Parent Teacher Association (PTA), classroom volunteers, etc.
- Screen all visitors/volunteers for symptoms upon every entry. Restrict from school property any visitor known to have been exposed to COVID-19. <u>See table "Planning for COVID-19 Scenarios in Schools."</u>
- Visitors/volunteers must wash or sanitize their hands upon entry and exit.
- Visitors/volunteers must maintain six-foot distancing, wear face coverings, and adhere to all other provisions of this guidance.

Hybrid/Onsite Plan

- All visitors will be met prior to entering the building to determine if they are non-essential or essential.
- Non-essential visitors will be restricted from entering the common areas and classroom settings (all areas beyond the office).
- Essential visitors will be screened visually and will answer the question sheet provided. They will wash their hands or utilize the hand-sanitizer before entering any common areas or classrooms. Visitors older than 5 years will wear a mask and follow the 6-foot social distancing and SAS guidelines.
- Surfaces in the lobby, door handles, counters, windows etc. are sanitized multiples times per day.

1h. FACE COVERINGS, FACE SHIELDS, AND CLEAR PLASTIC BARRIERS

OHA/ODE Requirements

- ☑ If a student removes a face covering, or demonstrates a need to remove the face covering for a short-period of time:
 - Provide space away from peers while the face covering is removed. In the classroom setting, an example could be a designated chair where a student can sit and take a 15 minute "sensory break;"
 - Students should not be left alone or unsupervised;
 - Designated area or chair should be appropriately distanced from other students and of a material that is easily wiped down for disinfection after each use;
 - Provide additional instructional supports to effectively wear a face covering;
 - Provide students adequate support to re-engage in safely wearing a face covering;
 - Students cannot be discriminated against or disciplined for an inability to safely wear a face covering during the school day.
- Face masks for school RNs or other medical personnel when providing direct contact care and monitoring of staff/students displaying symptoms. School nurses should also wear appropriate Personal Protective Equipment (PPE) for their role.
 - Additional guidance for nurses and health staff.

Protections under the ADA or IDEA

- ☑ If any student requires an accommodation to meet the requirement for face coverings, districts and schools should limit the student's proximity to students and staff to the extent possible to minimize the possibility of exposure. Appropriate accommodations could include:
 - Offering different types of face coverings and face shields that may meet the needs of the student.
 - Spaces away from peers while the face covering is removed; students should not be left alone or unsupervised.
 - Short periods of the educational day that do not include wearing the face covering, while following the other health strategies to reduce the spread of disease;
 - Additional instructional supports to effectively wear a face covering;
- For students with existing medical conditions and a physician's orders to not wear face coverings, or other health related

Hybrid/Onsite Plan

All SAS staff will wear face coverings or face shields when they are within six feet of students or each other. They may remove their face covering when working alone in a private office.

- All students will be required to wear a face covering or face shield unless they are protected under the ADA or IDEA or present a doctor's note.
- If a student removes a face covering or demonstrates a need to remove the face covering for a short-period of time, the teacher will implement grace and love for the current need. The teacher will encourage face covering protocol at the appropriate time.
- All students, whether they have a face covering or not, will remain an integral part of the school program and will be provided instruction.
- If ADA accommodations are needed for a staff member, limited exposure to the students will be implemented as much as possible.

- Consider required physical arrangements to reduce risk of disease transmission.
- Plan for the needs of generally well students who need medication or routine treatment, as well as students who may show signs of illness.
- Additional guidance for nurses and health staff.
- Students and staff who report or develop symptoms must be isolated in a designated isolation area in the school, with adequate space and staff supervision and symptom monitoring by a school nurse, other school-based health care provider or school staff until they are able to go home. Anyone providing supervision and symptom monitoring must wear appropriate face covering or face shields.
 - School nurse and health staff in close contact with symptomatic individuals (less than 6 feet) should wear a medical-grade face mask. Other Personal Protective Equipment (PPE) may be needed depending on symptoms and care provided. Consult a nurse or health care professional regarding appropriate use of PPE. Any PPE used during care of a symptomatic individual should be properly removed and disposed of prior to exiting the care space.
 - After removing PPE, hands should be immediately cleaned with soap and water for at least 20 seconds. If soap and water are not available, hands can be cleaned with an alcohol-based hand sanitizer that contains 60-95% alcohol.
 - If able to do so safely, a symptomatic individual should wear a face covering.
 - To reduce fear, anxiety, or shame related to isolation, provide a clear explanation of procedures, including use of PPE and handwashing.
- ☐ Establish procedures for safely transporting anyone who is sick to their home or to a health care facility.
- ☐ Staff and students who are ill must stay home from school and must be sent home if they become ill at school, particularly if they have COVID-19 symptoms. Refer to table in "Planning for COVID-19 Scenarios in Schools."
- ☐ Involve school nurses, School Based Health Centers, or staff with related experience (Occupational or Physical Therapists) in development of protocols and assessment of symptoms (where staffing exists).
 - Record and monitor the students and staff being isolated or sent home for the LPHA review.

- Daily logs must be maintained containing the following:
 - Name of students sent home for illness, cause of illness, time of onset, as per designated communicable disease surveillance logs; and
 - Name of students visiting the office for illness symptoms, even if not sent home, as per routine health logs
- Staff and students with known or suspected COVID-19
 cannot remain at school and should return only after their
 symptoms resolve and they are physically ready to return to
 school as directed in the Communicable Disease
 Management Plan.

2. Facilities and School Operations

2f. CLASSROOMS/REPURPOSED LEARNING SPACES

- Whenever possible fresh air will be introduced into classroom spaces.

2k. HEALTH SERVICES

OHA/ODE Requirements

2m. SCHOOL EMERGENCY PROCEDURES AND DRILLS

OHA/ODE Requirements

In accordance with <u>ORS 336.071</u> and <u>OAR 581-022-2225</u> all schools (including those operating a Comprehensive Distance Learning model) are required to instruct students on emergency procedures. Schools that operate an On-Site or Hybrid model need to instruct and practice drills on emergency procedures so that students and staff can respond to emergencies.

- At least 30 minutes in each school month must be used to instruct students on the emergency procedures for fires, earthquakes (including tsunami drills in appropriate zones), and safety threats.
- Fire drills must be conducted monthly.
- Earthquake drills (including tsunami drills and instruction for schools in a tsunami hazard zone) must be conducted two times a year.
- Safety threats including procedures related to lockdown, lockout, shelter in place and evacuation and other appropriate actions to take when there is a threat to safety must be conducted two times a year.
- ☑ Drills can and should be carried out as close as possible to the procedures that would be used in an actual emergency. For example, a fire drill should be carried out with the same alerts and same routes as normal. If appropriate and practicable, COVID-19 physical distancing measures can be implemented, but only if they do not compromise the drill.
- When or if physical distancing must be compromised, drills must be completed in less than 15 minutes.
- Drills should not be practiced unless they can be practiced correctly.
- ☐ Train staff on safety drills prior to students arriving on the first day on campus in hybrid or face-to-face engagement.

Hybrid/Onsite Plan

SAS follows the required safety drills for the state of Oregon. These drills will happen as scheduled with additional protocol for maintaining 6-ft distancing to the greatest extent possible.

- Safety drills at SAS take typically less than 10 minutes.
- Drill procedures will be taught prior to attempts of practice and will be scheduled to provide practice to all students.
- Staff receive training on all safety drills during presession through direct instruction, Safe School training, or meeting with the local public offices of support.

Students will follow the handwashing guidance for entering the school building following a drill.
